# Barclays Overseas Delivery Charge

Barclays Overseas Delivery Charge (ODC) is applied to your account when sending an outbound international payment where you have selected charging option OUR and have chosen to cover all costs in relation to the international payment, including the charges levied by the beneficiary's bank.

ODC is determined by the location of the beneficiary bank. For example, if you were to send GBP or US Dollars to Japan choosing charging option OUR, the ODC applicable for Japan would be applied to your account. ODC is applied at the time when your transaction is processed by Barclays and applied to the account from which your international payment is debited or alternatively your nominated charging account. You will see the ODC combined with your outbound Barclays International Payments Service (BIPS) tariff. ODC covers the MT103 payment processing costs which can be levied by third party banks for executing your international payments. The third party banks (i.e. banks excluding Barclays) typically recover their payment processing costs by sending a claim to the bank that sent them the MT103 payment instruction.

## Benefits of ODC

ODC is the MT103 third party bank charging model adopted by Barclays and may be different to what you have experienced with other banks. You may find that other banks do not charge an individual charge at the time of your transaction but instead apply third party bank charges retrospectively to your account once they have received a claim for processing charges from the bank to which they sent the MT103 to. There are distinct advantages of ODC for our customers, which is why Barclays have adopted this model:

- ODC gives you full visibility of the charges involved in sending your international payments at the time the payment is processed
- It gives you a clear understanding of when to expect your charges to be applied to your account. This allows you to easily control the availability of funds within your account to cover such charges

- ODC also allows easy reconciliation of transaction costs to the original transaction. This is because ODC is charged at the time the transaction is processed by Barclays rather than being retrospectively applied to your account following receipt of a claim for processing charges from the bank that we sent the MT103 to on your behalf
- Unlike similar propositions with other banks, Barclays ODC has no recourse to your business if claims from third party banks to Barclays exceed the ODC you paid. This gives you comfort that your ODC costs are truly fixed when making an international payment.
- This will also mean that you will not receive any refund where the charges levied by the 3rd party bank are lower than the ODC.

## The other charging options available are:

**BEN** – When selected, indicates you would like all charges relating to the transaction to be paid by the beneficiary.

**SHA** – When selected, indicates you would like to pay Barclays charges and the beneficiary will pay all other charges.

These options only apply to international payments and are not available to SEPA payments.

## USD cover charge

A £3 cover charge is levied for any payment made in US dollars which is going to a beneficiary outside the US.

For payments sent with charging options SHA or BEN this amount will be deducted from the principal amount being sent (in addition to the transaction fee in the case of BEN). For charging option OUR, the cover charge will be debited from the chosen charging account in addition to the transaction fee and any Overseas Delivery Charges.

## Overseas Delivery Charge – Charge List

Please find the below list of Overseas Delivery Charges. Please refer to the country which you are sending your international payments to within the table, as this will define the charge which will be applied to your account. If the country which you are looking to send funds to is not listed below, the ODC of £10 is applicable. Charges listed below are in GBP but if your account is in an alternative currency we will calculate and apply the currency equivalent to your account using the Barclays relevant exchange rate on the day. The payment charging bands for ODC are also listed in GBP.

Please be advised that the below charges are subject to change as they relate to third party bank claims. If charges were to change adversely you will be notified in advance of the change.
